The Sub-Committee recognised the concerns expressed by objectors however a number of issues raised did not fall within the remit of this application and therefore were not open to the Sub-Committee for consideration.

The Sub-Committee considered that the Applicant has run previous events under temporary events notices and had taken positive steps to mitigate any

noise emanating from those events. It was further considered that no Responsible Authorities had objected to the application, in particular the Council's Environmental Health department.

In considering the promotion of the four licensing objectives the Sub Committee did not deem it justified or proportionate to impose additional conditions restricting the use of the outside areas of the premises.

The Sub–Committee considered that granting the application was consistent with the Council's Statement of Licensing Policy.
