**LONDON ASHFORD AIRPORT (LYDD)
SUPPLEMENTARY INFORMATION TO PLANNING APPLICATIONS**

On behalf of our client, London Ashford Airport Limited, we are pleased to submit Supplementary Information for the current Planning Applications for expansion at London Ashford Airport (Lydd) ("LAA").

This Supplementary Information is in response to the public consultation on the two Planning Applications submitted by LAA in December 2006 for a new terminal building and runway extension, registered by Shepway District Council ("SDC") on 22 December 2007 and given reference numbers Y06/1647/SH and Y06/1648/SH respectively.


