# 10. Glossary

## Aircraft Movement

This is the departure and arrival of an aircraft at an airport. An aircraft that lands and takes off at an airport is classified as 2 (two) movements.

#### Aircraft Stand

Situated remotely or adjacent to the terminal building, stands are locations on an apron where day-to-day servicing activities are completed. This includes the enplaning and deplaning of passengers.

# Airport Surface Access Strategy

An ASAS should set out challenging short and long-term targets for increasing the proportion of journeys made to the Airport by public transport; the strategy, including green transport plans for those who work at the Airport, to achieve these targets, taking into account prospective growth at the Airport and background growth in traffic; and a system whereby the Forum can oversee implementation of the strategy.

#### Airside

The area of the Airport restricted to the public and does not permit general access.

## Air Taxi Movement

The movement of an aircraft operating on a non-scheduled service.

# Air Traffic Movement

Landing or take-offs of aircraft engaged on the transport of passengers, cargo or mail on commercial terms. All scheduled movements, including those operated empty, loaded charter and air taxi movements are included.

# Air Traffic Control

Provided at an airport by ground-based controllers who direct aircraft on the ground and in the air.

# **Air Transport Movement**

See Air Traffic Movement

# Apron

A defined area on the aerodrome provided for the stationing of aircraft for the embarkation of passengers, the loading and unloading of baggage and cargo and for parking.

## **AVTUR**

This is aviation fuel used by aircraft with jet and turbine engines.

# **AVGAS**

Aviation gasoline.

# **Balfour Beatty**

## Cargo Movement

Cargo Movement is a flight carrying solely freight and/or mail and associated cargo attendants.

# **Conservation Area**

Designation given by the Local Authority in accordance with Planning Conservation and Listed Buildings Act 1990 to areas of settlements, the character or appearance of which it is considered desirable to preserve and enhance.

# **Development Plan**

A plan prepared by a Local Planning Authority to guide development and land use.

## **Domestic Services**

Are services flown entirely within the United Kingdom, Isle of Man and Channel Islands.

# East of Devon Growth Point Team

A team to develop the Growth Delivery Plan for the Exeter and East Devon New Growth Point, which sets out a rationale for economic and housing growth, the key development opportunities, phased to show infrastructure requirements, and includes a summary of the investment we are looking to fund to support this.





# **Emission Trading Scheme**

An administrative approach used to control pollution by providing economic incentives for achieving reductions in the emissions of pollutants.

## **Environmental Impact Assessment**

(EIA) is an assessment of the likely positive and/or negative influence a project may have on the environment. They can be defined as the process of identifying, predicting, evaluating and mitigating the biophysical, social, and other relevant effects of development proposals prior to major decisions being taken and commitments made. The purpose of the assessment is to ensure that decision-makers consider environmental impacts before deciding whether to proceed with new projects.

# **Environmental Management Strategy**

The focus of environmental impacts and ways they can be minimised. The scope of the activities, resources or area that is to be improved environmentally varies considerably.

# **Exeter Corporate Aviation**

(ECA) is Exeter International Airport's dedicated corporate aviation facility for private aircraft.

## Freight

A term used to classify the transportation of cargo.

# **Galaxy Sarl**

A dedicated transportation infrastructure equity fund looking to achieve recurring medium-term income and long-term capital appreciation for its shareholders.

# **General Aviation**

General aviation refers to all flights excluding military and scheduled airline flights, both private and commercial. General Aviation flights range from gliders and powered parachutes to large, non-scheduled cargo jet flights.

# **General Aviation Movements**

Commercial movements including Air-Taxis, positioning and local movements and all non-commercial movements including private aircraft operations and aero-club instructed flights.

# **Gross Value Added**

(GVA) is a measure of the value of the goods and services produced in the economy, primarily used to monitor the performance of the national economy as well as the overall economic well-being of an area.

## Landside

That area of the Airport where the public have general access.

# Learning and Skills Council

Exists to make England better skilled and more competitive with the single goal: to improve the skills of England's young people and adults to ensure we have a workforce of world-class standard.

### Master Plan

An important document created by UK airport operators to indicate how they propose to take forward the conclusions on the future development at their individual airports supported by the White Paper. They will inform the local and regional planning processes and enable local people, businesses and other stakeholders to be aware of the proposals.

#### Microsoft MapPoint

Designed for everyday business use, MapPoint makes it easy to visualise business information on maps, illustrate points on maps and integrate maps into Microsoft Office documents.

# **Planning Policy Guidance Notes & Statements**

Planning Policy Guidance Notes (PPGs) and their replacements Planning Policy Statements (PPSs) are prepared by the government after public consultation to explain statutory provisions and provide guidance to local authorities and others on planning policy and the operation of the planning system. They also explain the relationship between planning policies and other policies which have an important bearing on issues of development and land use.

# Regional Climate Change Action Plan

# **Scheduled Services**

Services performed in accordance with a published timetable.



# **Science Park**

East Devon District Council, in partnership with Exeter City Council, the University of Exeter, Devon County Council and the Met Office, has commissioned consultants to prepare planning guidance on how a Science Park adjacent to the M5 motorway at Junction 29 can be developed.

# Skills Pledge

The Skills Pledge is a voluntary, public commitment by the leadership of a company or organisation to support all its employees to develop their basic skills, including literacy and numeracy, and work towards relevant, valuable qualifications to at least Level 2 (equivalent to five good GCSEs).

# Skypark

A brown field site on the northwestern side of Exeter International Airport, the Skypark development will be situated on land that forms the curtilage of the Airport. Envisaged as a modern business park in a quality landscaped setting, the development is designed for large-scale employment with a planned mix of business, industrial and distribution usage.

# **South West Regional Spatial Strategy**

The Regional Spatial Strategy (RSS) for the South West sets the spatial framework for the future development of the region over the period 2006 to 2026. It seeks to tackle the major challenges that the region faces over this period, including accommodating a substantial increase in population and a growing economy, tackling climate change and reducing the region's ecological footprint as defined by the consumption of natural resources and energy.

# **Strategically Significant Cities & Towns**
