Dear Mrs Barton

You called a week or so ago about the requirement for security fences at Lydd (London Ashford) Airport, and I promised to get back to you once I'd spoken with my aviation security colleagues. I'm sorry for the delay in responding.

I thought it might be easier to set out my colleagues' advice via an email. They've confirmed that :

- Lydd is as a qualifying airport under the provisions of the National Aviation Security Programme (NASP), and is therefore required to put up security fences to BS 1722 part 10 standard, or a wall, building or other obstacle which will inhibit unauthorised access.
- DfT would require an airport projects registration form, normally before the airport commences any security fence project. The form is only required in order to register the project.
- DfT would not be required to carry out a formal inspection of the fence.

I hope this is helpful, but if you need more detailed information on the security fence requirements or the NASP, let me know and I will ask one of my colleagues to contact you directly.

Please note I will be working away from the office tomorrow, Wednesday 20 and Thursday 21 July, and won't have access to my email or telephone.
