In support of the Government's Strategic Siting Assessment for Dungeness 'C' new build NPP, the HSE's Nuclear Directorate carried out a demographic assessment based on night time residential population. HSE concluded that, at a strategic level, any likely power station development within the nominated site boundary complied with semi urban demographic criteria. The HSE's final assessment (copy attached) was published in the Department of Energy and Climate Change's Draft Nuclear National Policy Statement (Part 5) and subsequently in the Government Response to the consultation on the draft NPS's for Energy Infrastructure: and
