Hi David,

Yes, we have previously quoted £30million plus per annum as being spent in the local community as result of the operation of Dungeness B and that figure would still be reasonable to use.

For info, in terms of our new build project at Hinkley Point C, which is for two new EPR units, we estimate the benefits to Somerset and the surrounding region as £100m per annum being spent in salaries and the supply chain during construction, £40m per annum in salaries spent in community during operation.

Hope this helps.
